MEMORANDUM

Subject: Red Light Camera Pilot Program – Yellow Light Certification

Date: June 26, 2012

On June 19, 2012, the Department of Transportation (DOT) informed certain municipalities that the issuance of red light camera tickets at 63 of the State's 85 red light camera intersections should cease immediately and until such time that the DOT is provided with the proper certification by the municipal engineer that the duration of the amber light at the intersection(s) is in compliance with the time parameters established in N.J.S.A. 39:4-8.14(a)(3).

According to the communication from DOT, ticket issuance can resume at an identified red light camera intersection once DOT has received the required certification from the municipality. Municipalities have up to 45 days to submit the proper certification. Unless otherwise advised by DOT, red light camera tickets may continue to be issued at the 22 red light camera intersections not affected by the DOT directive. The attached list shows the 63 red light camera intersections affected by the DOT directive and the 22 intersections not affected

The purpose of this memorandum is to provide general guidance to the municipal courts regarding the handling of pending red light camera tickets that have been issued at the affected intersections. If a defendant contacts the court to contest an unpaid red light camera ticket issued at one of these intersections, the court should put the case on "Held" status pending the municipality's submission of the required certification to DOT. The same should be done for disposed cases where the defendant has contacted the court to ask that the matter be reopened on the basis of the DOT's action.

If a ticket was previously contested and the case already has been scheduled for court, the matter should be rescheduled and also place on "Held" status pending the municipality's submission and confirmation by DOT that the certification is acceptable. However, defendants with pending matters may, if they so choose, still plead guilty and pay their fine through the court's violations bureau or through NJMCDirect.

Pursuant to your request, this office visited the intersections of Berlin Avenue (CR 702) & Glendale Road (CR 673) and Laurel Road (CR 673) & Warwick Road (CR 669) on December 18, 2012 (off peak timing) to observe the total traffic signal times and the length of duration of the amber phases of each signal. The results of the observations are as follows:

1. Berlin Avenue (CR 702) & Glendale Road (CR 673) (a.k.a. White Horse Road)

- Berlin Avenue WB Approach: Total Cycle Time - 90 seconds
Amber Phase Duration – 3.75 seconds
- Berlin Avenue EB Approach: Total Cycle Time – 90 seconds
Amber Phase Duration – 3.98 seconds
- Glendale Road NB Approach: Total Cycle Time – 90 seconds
Amber Phase Duration – 3.84 seconds
- Glendale Road SB Approach: Total Cycle Time – 90 seconds
Amber Phase Duration – 3.89 seconds
Left Turn Amber Phase – 3.03 seconds

2. Laurel Road (CR 673) & Warwick Road (CR 669)

- Laurel Road NB Approach: Total Cycle Time – varied 95 to 110 seconds
Amber Phase Duration – 4.95 seconds
- Laurel Road SB Approach: Total Cycle Time – varied 95 to 110 seconds
Amber Phase Duration – 4.94 seconds
- Warwick Road WB Approach: Total Cycle Time – varied 92 to 110 seconds
Amber Phase Duration – 3.87 seconds
- Warwick Road EB Approach: Total Cycle Time – varied 92 to 110 seconds



Pursuant to NJSA 39:4-8.14a(3), the intersection in question (a) has a minimum duration of the amber light at the traffic control signal of 3 seconds if at least 85% of the vehicular traffic approaching the signal is traveling at a speed of 25 mph or less, and (b) for each five mile increase in speed of vehicular traffic referred to in (a) of this paragraph above 30 mph this minimum duration shall be increased by $\frac{1}{2}$ second.
