SCHOOL CROSSING: "that portion of a highway where school children are required to cross the highway in the vicinity of a school."

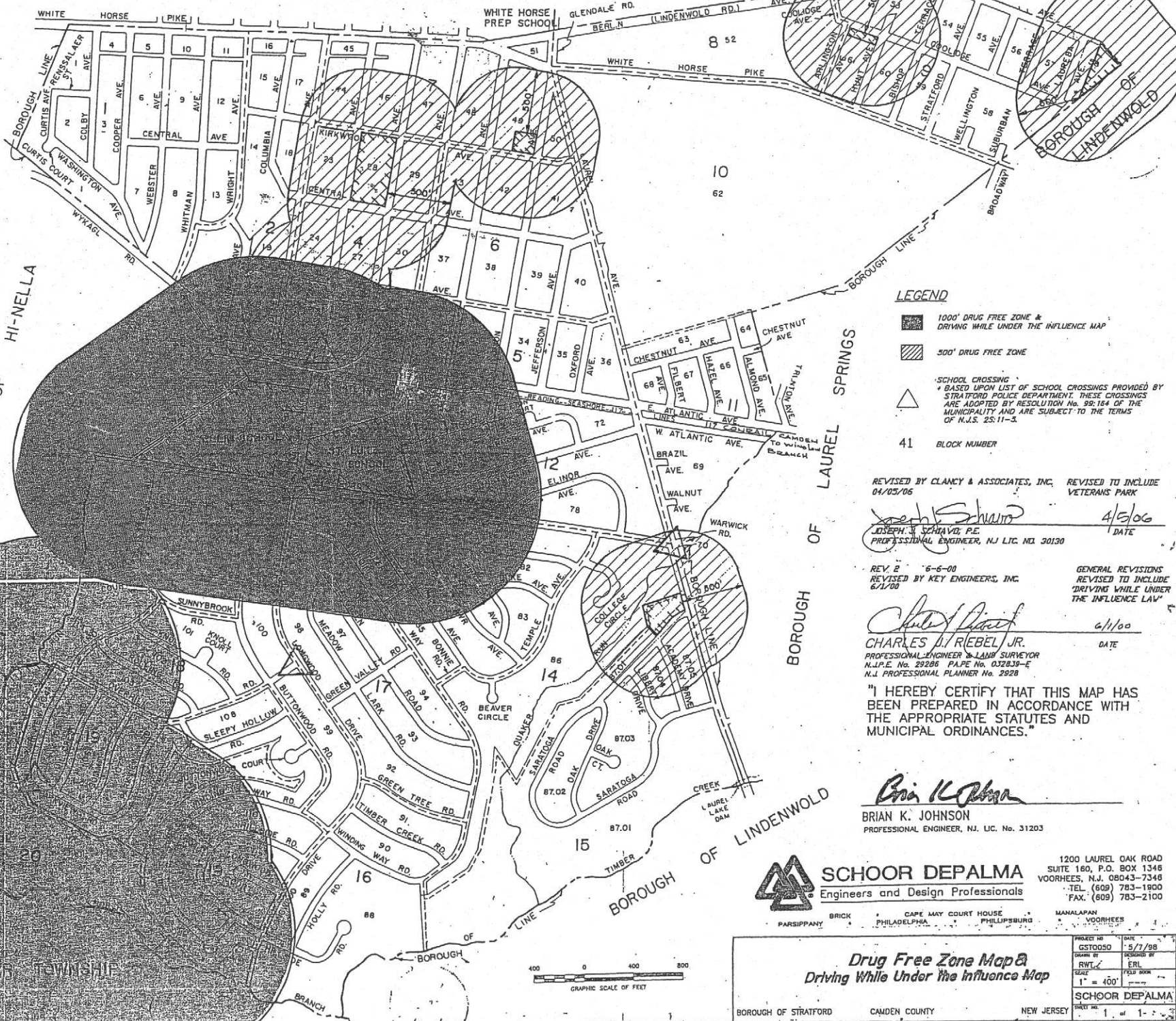

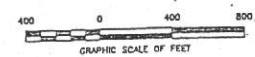
